

## Decision No (DD-04-25-001) Concerning the designation of (15) companies as supporters of the usurping Zionist entity

### First: Legal Basis:

1. Pursuant to Law No. (5) of the year 1445 AH concerning the designation of states, entities, and persons hostile to the Republic of Yemen.
2. And pursuant to the Sanctions Regulation on Supporters of the Usurping Zionist Entity (SR-SUZE), issued on 26 Ramadan 1446 AH, 26 March 2025, and the authority granted to The Humanitarian Operations Coordination Center (HOCC) in accordance with Article (7 - b) of the same regulation.

### Second: Substantive Justifications:

1. Given that the entities listed in the table below are involved in supplying the Zionist enemy forces with advanced weapons systems, missiles, munitions, military equipment, and other items directly linked to war crimes, crimes against humanity, and acts of genocide committed by the usurping Zionist entity in Gaza since 07 October 2023 to the present, which continue to claim the lives of innocent Palestinian civilians.
2. Based on the contents of the administrative record related to this matter, it has been concluded that there is sufficient factual basis to determine that the relevant conditions set forth in Article (8) of the (SR-SUZE) apply to the following entities:

**Based on the foregoing, it is hereby decided as follows:**

1. The entities listed in the above table are designated as supporters of the usurping Zionist entity.
2. The entities listed in the above table shall be included in the Sanctions List of Supporters of the Usurping Zionist Entity (SUZE).
3. Appropriate sanctions shall be imposed on the entities listed in the above table in accordance with Article (38) of the (SR-SUZE).
4. This decision shall enter into force as of the date and time of its issuance and shall be published on the HOCC's official website.

**Note:** This decision is not intended to create any right or benefit enforceable by any party against the Republic of Yemen or its institutions. However, this shall not prejudice any established rights to challenge this decision in accordance with the procedures set forth in the relevant regulation.
